*Repeat Camppower Support Staff pricing applies only to the first 100 completed Camppower applications. All other returning Camppower applications will be subject to first-timer program fees and pocket money. Repeat Counselor applicants from Israel will be assessed additional Camp America program fees. Please refer to the applicant profile for correct pricing. Camp America has a limited number of 3 year + Camp Counselor Visas and therefore will not accept 3 year + counselors who have not completed at least one year with Camp America.

Notes on Fees

- All staff selected are subject to a \$35 SEVIS tracking fee.
- Additional pocket money is payable according to the following schedule: First year staff should be paid an additional \$200/week after the first nine weeks (residential camp) or ten weeks (day camp), including pre-camp.
- Camps agree to reimburse participants arriving on a Camp America flight for travel to camp expenses. Surcharges for alternate arrival gateways are listed in the 2024 one-way flight prices document.
- Camp America imposes a cancellation penalty for participants "dropped" without a valid reason. The cancellation penalty for 2024 is \$400 per participant.
- Two thirds (66%) of the total amount payable is due June 1, and the balance on August 1. A 3% finance charge will be assessed per month for late payments after September 1.
- Should Camp America encounter constraints with regard to allocation of U.S. State Department J-1 visa application Forms DS-2019, the program may accordingly set deadlines, quotas or other restrictions on applicant qualification for repeat counselor fee category.
- Pocket money guidelines apply to camps that are exempt from minimum wage requirements on federal, state and local levels. Camps that are not exempt are to provide additional compensation to participants in order to fulfill such requirements as specified in U.S. Department of State regulations governing the J-1 Exchange Visitor Program.
- Camps electing to cover fees typically paid by participants to Camp America are subject to the participant refund policy, which includes some non refundable fees.
- "Experienced Counselor" refers to an applicant who has successfully completed at least one season at a different camp on a designated J-1 camp counselor program.
- Participants are to be paid from their Camp America start date, which is their arrival on camp date, to their Camp America end date.
- There are no fuel surcharges in 2024
